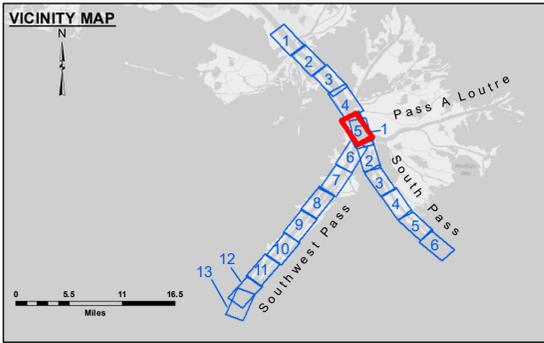

WEST HALF OF THE CHANNEL

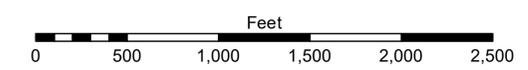
