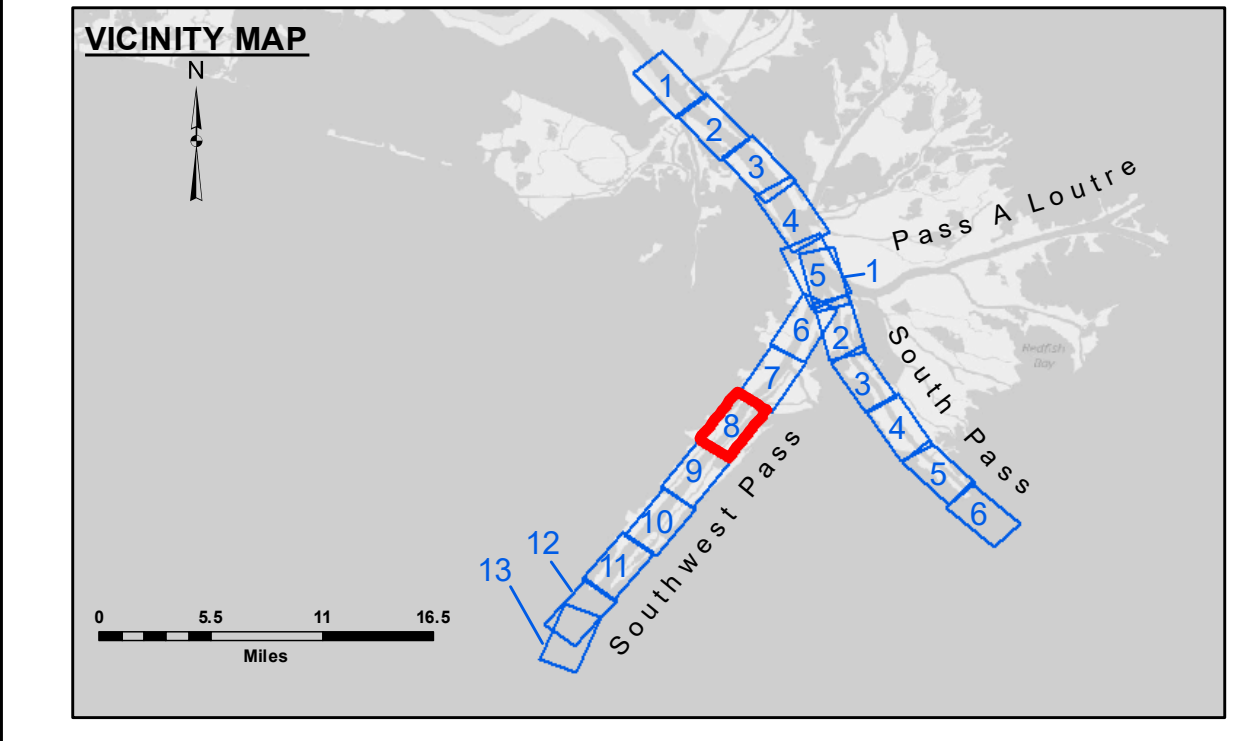


**CUTTERHEAD DREDGE CAPT FRANK
