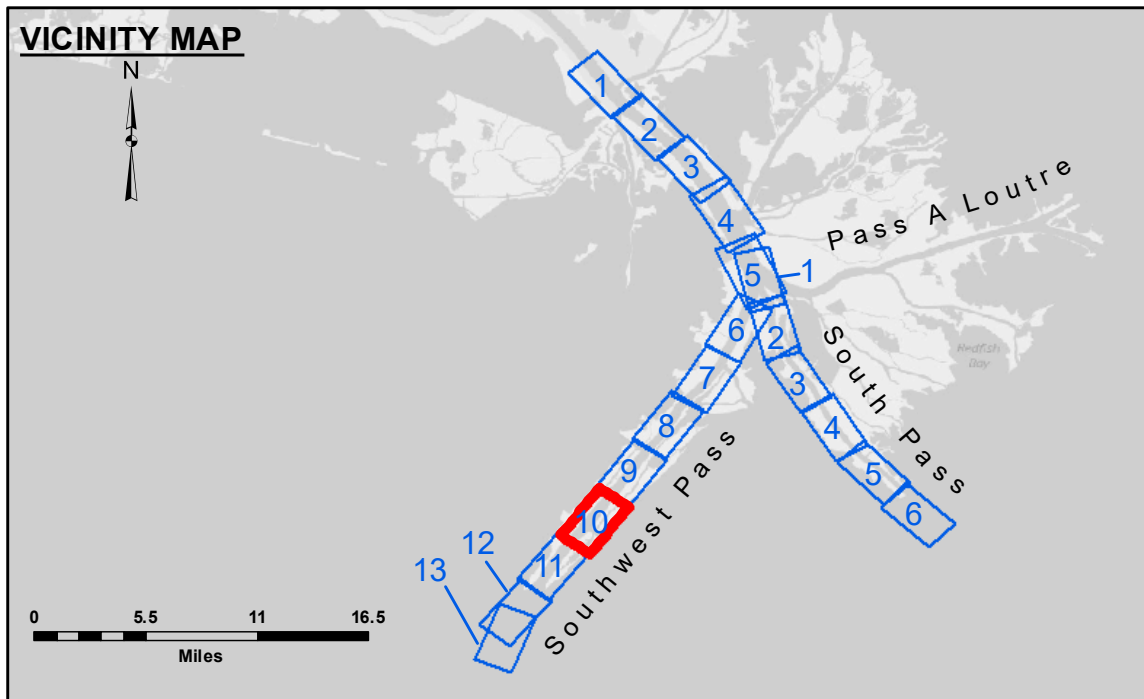


**CUTTERHEAD DREDGE CAPTAIN FRANK
